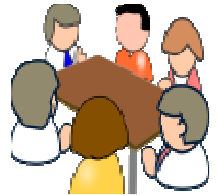

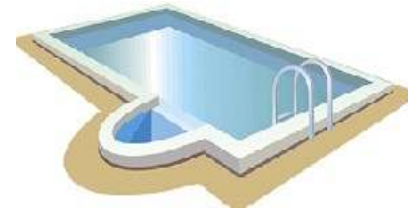
General Meeting of Pleasant Run Farms Civic Association

PLEASANT RUN FARMS GENERAL MEETING MINUTES

A Board Meeting of the Pleasant Run Farms Civic Association was held March 17, 2016 at the home of Anna Fields. The following are the minutes from the meeting.

The meeting was called to order at 7:10pm.

Reading of the minutes from prior meeting:

James Ciolino asked if everyone had read the minutes from February. Motion was made to accept the minutes as written, motion was seconded and the minutes were approved for acceptance.



Board Reports:

President: James Ciolino –

James introduced a guest, Al Eichorn, who is interested in joining the board as a representative to the senior / retiree portion of the PRF community. James made a motion to add this position to the board members listed in the by-laws; motion was seconded and approved. The board will introduce the position at the general meeting in April and allow the members in attendance to vote on Al (and/or other(s) interested in filling the position) to serve in this role.

James had a meeting with Mike Gould, Springfield Township, and they discussed plans to spruce up the area around the flagpole at Clifford George. James talked about adding a sign in this area and the board discussed implications (cost, change to look of the area now, especially if the new sign looks a lot different than the memorial plaque and is placed very close to that area). The board agreed to revisit the topic in future meetings, as well as to see what the township's master neighborhood group might come up with in terms of signage for various neighborhoods. The general cleanup planned by the township (basically to replace older bushes) will proceed.

It was also mentioned that the master neighborhood group is focused on what happens to properties that are vacant and/or available with possibility of becoming a type of business the nearby neighbors might not want. For instance, concerns near PRF include the future disposition of the Welch Elementary property, the businesses – currently vacant – that were Chasers and Arbor Designs, as well as issues with apartment complexes near the Farms. These are areas in which the township might have some sway with attracting new owners and/or new uses that will be beneficial to the neighborhood.

Vice President: Anna Fields –

Anna stated that she did attend the State of the Township meeting in early March.

Treasurer: Ed Mayer –

Ed presented the financial report. Account balance as of 3/17/16 was \$9,666.17. Motion was made to accept the financial report, motion was seconded and the financial report was approved for acceptance.

Secretary: Connie Fears –

Connie had no report other than a reminder that the PRFCA scholarship deadline is March 31.

Athletic Director: John Buschmann –

Spring sports signups has been completed. Things are going well. There's a planned field cleanup on April 2.

Communications: Venita Vivians –

Venita was unable to attend the meeting.

Membership Report:

Membership chair's position is currently open. James and Linda worked to update and reprint the PRFCA informational tri-fold. James shared plans for the board to assist in a membership drive. Each board member is to deliver a tri-fold, information about the pool and a membership form to every house in their assigned section of the neighborhood, speaking with as many residents as possible to encourage greater membership in PRFCA.

Community Activities: Linda Boylson

Linda stated that we are ready to host the Easter Egg Hunt on March 20 at Clifford George. Future community events include Great American Cleanup (to be held in the Farms on April 16), neighborhood garage sale on the 3rd Saturday of May, Fourth of July parade and Luminaria in December. Discussion was held on the idea of doing a family event in the fall.

Pool: Erin Knox –

Erin was unable to attend the meeting, but pool board member Susan Scheib sent a report. They've begun the process to open the pool for the 2016 season. Cleanup dates are March 19, April 16 and May 14. Several high school students are already lined up to help; other students or community volunteers are welcome. They have a new design for the swim club logo and the garage / storage building in the parking lot will be repainted. They received information on applying for the Springfield Township neighborhood grant (applications due April 8); they'll be applying for fund to make some permanent improvements to help extend the longevity of the swim club.

Old Business:

Ed reminded the board that PRFCA has a new website name – PRFarms.org - which will automatically link to the old site (and the old site can still easily be found via internet search). This makes it easier to put the website name on the sign at Clifford George, as well as on certain other communications.

New Business:

None at this time

Being no further business to come before the Board, the meeting was adjourned at 9:09pm.
