PLEASANT RUN FARMS GENERAL MEETING MINUTES

A General Meeting of the Pleasant Run Farms Civic Association was held April 28, 2016 at 7:30pm at Welch Elementary. The following are the minutes from the meeting.

The meeting was called to order at 7:32pm. Nineteen members of the community were present.

Presentation of PRFCA 2016 Scholarship:

James Ciolino presented the 2016 Scholarship to this year's winner, Ashley Carroll. Ashley is a senior at Northwest High School and is planning to attend Case Western Reserve University in the fall.



Guest from Northwest Local School District:

Chris McKee discussed the status of the Welch property. The district wants the community to be informed and have input as much as possible.

Per Ohio Department of Education rules, the district must first make the school building, at appraised value, to an interested charter school. If no interested school wishes to purchase the property, it may be sold at auction; and if no buyer presents at that time, the district will likely move to demolish the building, then retain the land until it is possible to be sold.

The reason for demolition is that the district does not want to maintain an empty building. The Bevis property is a good example, as Chris discussed the issues with that building being vacant, broken into, and the carrying costs to the district of having a building still standing on that property. There are no solid plans at this time; rather, Chris was just explaining the possible path that this will take in the future.

Welch will be used for two more school years. The new elementary school, to be built on the PRE property, will open in August, 2018.

Reading of the minutes from prior meeting:

Connie Fears gave a brief review of the minutes from the January, 2016 General Meeting. Motion was made to accept the minutes as written, motion was seconded and the minutes were approved for acceptance.

Board Reports:

President, James Ciolino –

James stated that the board has been discussing the addition of a board representative position for a Seniors' Activist. This role would include activities for senior adults and neighborhood watch. Motion was put forth, seconded and the motion was approved by members in attendance. Information will be published in the Memo on this role. Interested persons can contact James with questions and/or to express interest in joining the board to fill this role.

James discussed plans for a new sign, to announce Springfield Township and Pleasant Run Farms, near the area of Clifford George fields. Question was asked on how much this sign will cost; and James stated that the township is interested in providing assistance with signage, as they are looking at having entrance signs in all the township neighborhoods.

Vice President: Anna Fields –

Anna attended the April 12 Springfield Township trustees meeting. They have some community activities coming up. She recommends checking the township website for event information. For example, there's a play on April 29; a drop-off for expired pharmaceuticals on April 30; and an auction planned for May 21.

Treasurer: Ed Mayer –

Ed presented the financial for 2016 to-date. As of 4/28/2016, there is balance of \$8142.40 in the account.

Secretary: Connie Fears –

Connie stated that she has nothing new to report.

Athletic Director: John Buschmann –

John was unable to attend the meeting.

Communications: Venita Vivians –

Venita was unable to attend the meeting.

Membership Report:

Membership chair's position is currently open. Interested persons can contact James with questions and/or to express interest in joining the board to fill this role.

Community Activities: Linda Boylson –

Linda reported on plans for community events: neighborhood garage sale (3rd Saturday in May, rain or shine), landscape contest (June), parade (July 4), and Luminarias (December).

Great American Cleanup didn't happen in April; however, it could still be done in May, if anyone would like to volunteer to coordinate the event (she'll provide guidance).

Linda mentioned that the landscape contest winners will be announced on the day of the July 4th parade. Also, she invites participants for the parade - floats, motorcycles, classic cars, scout troops, etc. - and there will be a few prizes (ToysRUs gift cards) given for kids with the best decorated bicycles. She's open to doing a community activity in the fall and would like interested people to contact her with ideas.

The Easter Egg Hunt went very well. There were 43 children in attendance to hunt for 800 eggs (thanks to the seniors who filled them). Thanks, also, to James Ciolino for organizing a basket raffle.

Pool: Erin Knox –

Susan Scheib reported for Erin on the status of the pool. Work has been underway to begin preparing the pool for the 2016 summer season. The gate issue has not been resolved yet, but will be since it is a requirement to be able to open the pool this year. The neighborhood grant has been applied for and they're waiting for response; the hope is that funding would come through to take care of the gate and some fencing issues and to cover a process to convert the paint in the pool to a material that would last ten years (instead of current paint which has to be applied yearly).

There will be a drawing held at the end of May for membership fee refund to the winner; entrants will be those who purchase a membership during the month of May. Also, the pool will offer a special price during May for those who join the pool and the swim team at the same time.

The pool held a cleanup event on April 16. Several high school students helped out. There will be another cleanup day on May 14. Anyone wishing to volunteer is welcome; please send an email to prfswimclub@yahoo.com.

The pool needs a treasurer for this year. Training will be provided. If interested, please contact the pool as soon as possible (prfswimclub@yahoo.com).

Seven lifeguards have been hired for this summer. Applications are still being accepted for additional help to make sure they'll have full lifeguard coverage for the summer.

The pool will open for Memorial Day weekend (May 28, 29, 30) and will be open weekends only until school is out. It'll be open daily until school is back in, then open weekends only until Labor Day.

Old Business –

No old business to be discussed.

New Business –

James discussed the possibility of some portion of PRF greenbelt becoming a park area, with use of township, county and/or state grant funding to make that happen. One area of interest would be the 33 acres behind Hazelgrove and Haviland. Comments, ideas and discussion on this topic are invited.

James opened the floor to questions or comments from the community members present at the meeting. One community member expressed concern about houses in the neighborhood that seem to be falling into disrepair; possibly because the occupants are physically unable to keep up with the maintenance needs of the homes. He asked if there are any groups who might go do some yard and/or repair work as a community service.

Also mentioned was a vacant home with overgrown grass. In this case, there may be a possibility of reporting it to the township for action. Sometimes the township is able to contact the owner (or bank, if bank-owned) to request that the needed maintenance be done.

Being no further business to come before the Board, the meeting was adjourned at 8:24pm.

Next General Meeting will be held on September 22 at 7:30pm in Welch Cafeteria.
